



AGREEMENT:

On behalf of myself, my spouse, and each Child designated (my "Child") I enter into this Registration Form Agreement ("Agreement") with just playin' around, LLC, regarding the provision by just playin' around, LLC, of a supervised, indoor play environment for my Child(ren).

- I. Facility Use: Subject to this agreement and other terms as drop in, short term Child care for my Child on a flexible time basis which includes use of facilities and participation in play and play activities. Just playin' around, LLC facilities may only be used for periods of four (4) hours or less on a regular basis. If for any reason a Child is present more than 4 hours, I agree that this will not occur on a regular basis and does not constitute regular care. Just playin' around, LLC does not provide transportation or take field trips.
- II. Future Visits: This agreement, the registration form and the Child Information form will be kept on file at just playin' around, LLC, and will constitute binding obligations for any future visits my Child may make to just playin' around, LLC. However, this agreement does not obligate just playin' around, LLC, to continue to provide services, and just playin' around, LLC reserves the right to refuse admission to any child for any reason without liability.
- III. Payment: Payment for just playin' around, LLC services will be due at the time of each check-out. This payment can be made by cash, check or charge for the amount calculated by multiplying the time elapsed from check-in time to check-out time. The posted amount will be charged along with any other agreed to charges such as meals and retail items. If a package of times has been purchased, your time will be debited against your package. Just playin' around, LLC may refuse to accept payment by check and may charge a fee of \$35.00 for any returned check. Just playin' around, LLC reserves the right to ask for payment in advance. Any changes in the fees will be posted for at least 30 days.
- IV. Health Policies: I agree that my "Child" is in excellent health and physical condition and has no medical, psychological, physical, or mental condition, which has not been disclosed to just playin' around, LLC on the attached Registration Form. My Child does not have any infectious, contagious, or communicable diseases. Illness: In the event that my child should become ill with a contagious illness, I agree to contact just playin' around, LLC as soon as possible to enable just playin' around, LLC, in its discretion to notify each family of all the children who may have been exposed.
- V. Medical Procedures: 1. General Medical Guidelines/Discretion: Although just playin'

around, LLC tries to provide a safe environment; it is possible that my Child could get injured. In this event, I authorize just playin' around, LLC to follow its internal procedures, including simple first aid as reasonably appropriate. However, I understand that just playin' around, LLC shall not be required to strictly follow those guidelines when, in just playin' around, LLC's judgement, circumstances require otherwise. 2. Medical Authorization: In the event that just playin' around, LLC determines that emergency medical attention is necessary for my Child, I authorize just playin' around, LLC to act as an agent for me and give permission for my Child to be attended by a physician in such circumstances as just playin' around, LLC deems necessary.

VI. Safety/Indemnity: I agree that just playin' around, LLC may take action when it considers prudent to protect the safety of my Child, and other children visiting just playin' around, LLC. I further agree to indemnify, defend, and hold harmless just playin' around, LLC, (and partners, directors, agents, and employees) from and against all actions, claims, or liability, including attorney fees and court costs directly or indirectly caused by my Child or resulting from any inaccuracy or omission made by me in completing the Registration Form.

VII. Additional Requirements: As a condition to my use of just playin' around, LLC, I have accurately completed and signed the Registration Form and Releases. I understand that just playin' around, LLC, will rely on this information in caring for my Child.

I agree to pay all costs and attorney fees arising out of any action relating to this Agreement, the Registration Form, or the Release for collection purposes, or otherwise.

I HAVE READ THE ABOVE CAREFULLY AND HAVE FULLY UNDERSTOOD THE CONTENT AND CONSEQUENCES OF THIS AGREEMENT BEFORE SIGNING.
